FOR THE PURPOSE OF VOTING ON THE FOLLOWING PROPOSITIONS:

PROPOSALS

LAKETOWN TOWNSHIP, PRECINCT 1, HOLLAND COMMUNITY SWIMMING POOL MILLAGE PROPOSITION – RENEWAL/ADDITIONAL AUTHORIZATION (This millage would renew the previously authorized 1.0 mill levy, which expires on December 31, 2018, for the operation of the Holland Community Aquatic Center.) Shall the limitation on the amount of taxes which may be assessed against all property (both homestead and non-homestead) in the Holland Area Community Swimming Pool Authority (whose geographic boundaries are coterminous with those of the Holland School District) be increased to the amount of 1 mills (\$1.00 on each \$1,000) on taxable value for a period of five (5) years, 2019 through 2023, inclusive, to provide funds to enable the Authority to own, operate, and maintain a community swimming pool and shall the Authority be authorized to levy said tax? If this millage is approved and levied, it is estimated that it will result in a revenue of \$1,285,072 being collected by the Authority in the 2019 calendar year.
