**ORDINANCE NO. 194  
PARKING VIOLATION AMENDMENT ORDINANCE**

An Ordinance to amend the Parking Violation Ordinance, Ordinance No. 43, specifically regarding penalties for violation of the parking regulations, and to provide for the effective date of this Ordinance.

THE TOWNSHIP OF LAKETOWN, COUNTY OF ALLEGAN, STATE OF MICHIGAN, ORDAINS:

Section 1. AMENDMENT. Section 7 of the Laketown Township Parking Violation Ordinance shall be amended in its entirety to state as follows:

Section 7. OFFENSES AND FINES.

Parking too far from curb .....	\$50.00
Parking in handicap parking zone.....	\$100.00
Angle parking violations .....	\$50.00
