Agricultural	47.59%	1.0506
Commercial	43.76%	1.1426
Residential	49.13%	1.0177
Developmental	49.68%	1.0064
Timber Cutover	50.00%	1.0000
Industrial	50.13%	0.9974
Personal Property	50.00%	1.0000

It is estimated that the Equalization factor for 2021 for both real and personal property will be 1.00. The assessment ratio is 50%.
