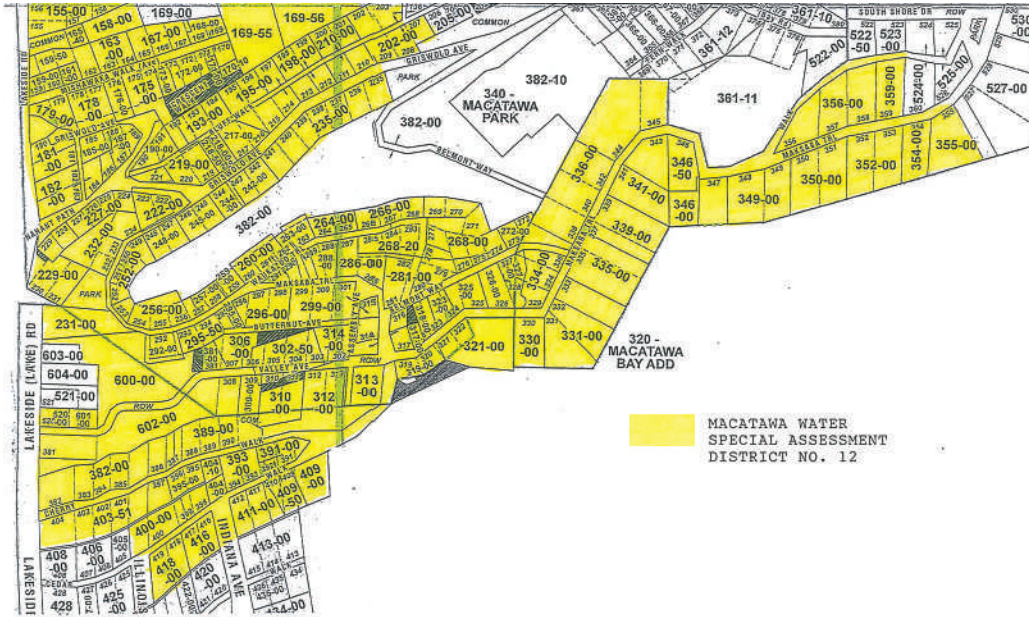

TAKE NOTICE that a revised special assessment roll has been prepared and is on file in the office of the Township Clerk for public examination. Said special assessment roll has been prepared for the purpose of assessing the cost of the following described improvements to the above property benefitted therefrom: the acquisition, construction and financing of water mains and related appurtenances to be connected to the Holland City Water system. Such water mains shall consist of approximately 9,000 linear feet and will include valves, fire hydrants, booster station, roadway replacement and other appurtenances. These water main improvements will be located as follows: in the public rights-of-way in Bay Road and South Shore Drive and in public rights-of-way and easements in the Macatawa Park Subdivision, Macatawa Bay Subdivision, and Lakeside Addition to Macatawa Park Subdivision in Laketown Township, Allegan County, Michigan.

TAKE FURTHER NOTICE that the Township Board will meet on the 26th day of August, 2015, at 7:00 p.m., prevailing Eastern Time, at the Township Office, 4338 Beeline Road, Holland, Michigan 49423, for the purpose of reviewing said assessment roll and hearing any objections thereto.

TAKE FURTHER NOTICE that said special assessment roll constitutes an amendment and revision to the special assessment roll confirmed for Water Special Assessment District No. 12 by Resolution #5 of the Township Board on November 13, 2013, to reflect actual project costs as bid and to revise the first installment due date.

TAKE FURTHER NOTICE that appearance and protest at this hearing is required in order to appeal the amount of the special assessment to the State Tax Tribunal if an appeal should be desired. A property owner or party in interest, or his or her agent, may appear in person at the hearing to protest the special assessment or may file his or her appearance by letter delivered to the Township Clerk at or prior to the meeting to be held on August 26, 2015 and his or her personal appearance shall not be required. The Property owner or any person having an interest in the property subject to the proposed special assessments may file a written appeal of the special assessment with the State Tax Tribunal within thirty-five (35) days after confirmation of the special assessment roll, but only if that special assessment was protested at this hearing.
