EXHIBIT A
ORDINANCE NO. 202
ZONING MAP AMENDMENT ORDINANCE

An Ordinance to amend certain portions of the Zoning Ordinance and Map of Laketown Township, Allegan County, Michigan, specifically by rezoning the land described below from R-1 Rural Estate District to R-2 Low Density Residential District.

The Township of Laketown, County of Allegan, and State of Michigan, Ordains:

Section 1. **Amendment.** That the Zoning Ordinance and Map of the Township of Laketown, Allegan County, Michigan, said map being incorporated by reference in the Zoning Ordinance for the Township of Laketown pursuant to Section 38-163 thereof, be and the same is hereby amended, changed and altered so that hereafter the lands hereinafter described shall be zoned as and included in the R-2 Low Density Residential District on said Zoning Map. Said lands are described as being in the Township of Laketown, Allegan County, Michigan, described as follows:

Part of the NW 1/4 of Section 2, T4N, R16W, Laketown Township, Allegan County, Michigan, described as: Commencing at the West ¼ corner of said Section 2; thence N89°20'59"E1357.78 feet along the South line of said NW 1/4; thence N00°49'11"W 633.00 feet along the East line of the West 33.00 feet of the East 1/2 of said NW 1/4 to the PLACE OF BEGINNING of this description; thence N00°49'11"W 295.65 feet along said East line; thence N89°20'59"E 221.00 feet; thence S00°49'11" E 295.65 feet; thence S89°20'59"W 221.00 feet to the place of beginning.

Section 2. **Effective Date.** The foregoing amendment to the Laketown Township Zoning Ordinance and Zoning Map was approved and adopted by the Township Board of Laketown Township, Allegan County, Michigan on June 9, 2021, after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended. This Ordinance shall be effective on June 24, 2021, which date is eight days after publication of the Ordinance as is required by Section 401 of Act 110, as amended, provided that this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110, as amended.
