**NOTICE OF PUBLIC HEARING**

TO: CITIZENS AND RESIDENTS OF THE TOWNSHIP OF LAKETOWN, ALLEGAN COUNTY, MICHIGAN.

PLEASE TAKE NOTICE that on the 7<sup>th</sup> day of October, 2020, a public hearing will be held by the Laketown Township Planning Commission in the tent that is adjacent to the Carriage House at The Felt Estate, 6597 138<sup>th</sup> Avenue, Holland, Michigan, 49423 at 6:00 p.m., local time, to hear and consider the adoption of the 2020 Laketown Township Master Plan. An open house to review the master plan with our planners will begin at 5:00 p.m. at the same location

Section 1

The following is a summary of the proposed Master Plan for Laketown Township.

The proposed Laketown Township Master Plan is a new document that references previous Township Master Plans from 1991, 1996, 2005, as well as the 2008 Blue Star Highway Sub-Area Plan. The proposed Master Plan recommends means to manage residential, commercial, industrial, and agricultural land use, the natural environment, utilities, transportation networks, recreational opportunities, public places, and the linear relationship of the landscape and its uses. The Plan consists of text, maps, charts, and other descriptive content that provides the recommendations of the Planning Commission for the physical development of the Township.

Section 2

Any person interested in these matters may appear at such hearing in person or by agent or attorney. Written comments concerning these matters may be filed prior to the hearing with the Laketown Township Manager, Laketown Township Hall, 4338 Beeline Road, Holland, Michigan, 49423 (Phone 616-335-3050), between 7:30a.m. and 5:00 p.m., Monday through Friday.
