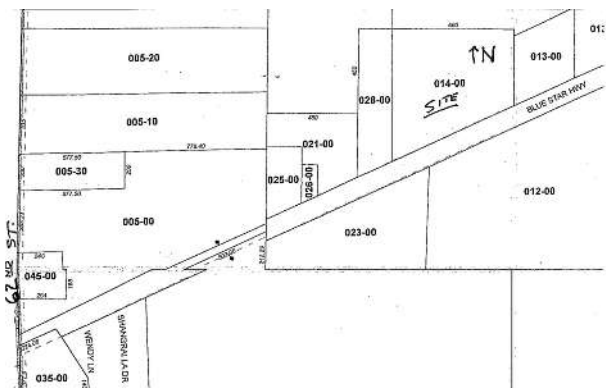


**NOTICE OF PUBLIC HEARINGS
ON PROPOSED AMENDMENTS TO THE
LAKETOWN TOWNSHIP ZONING ORDINANCE
AND ZONING MAP**

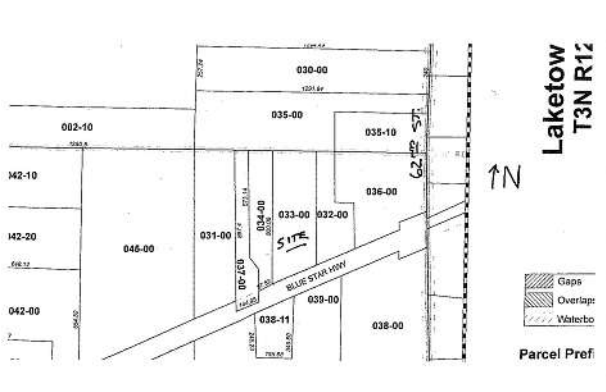
TO: THE CITIZENS AND RESIDENTS OF THE TOWNSHIP OF LAKETOWN, ALLEGAN COUNTY, MICHIGAN

PLEASE TAKE NOTICE that on the 2nd day of November, 2016 public hearings will be held by the Laketown Township Planning Commission in the Township Hall of Laketown, 4338 Beeline Road, Holland, Michigan 49423 (Telephone (616) 335-3050, Fax (616) 335-5459) at 7:00 p.m. local time to hear and consider proposed amendments to the Laketown Township Zoning Ordinance and Zoning Map. The amendments pertain to the following items:

- (1) An Ordinance to amend certain portions of the Zoning Ordinance and Map of Laketown Township, Allegan County, Michigan, specifically by rezoning the land described below from R-1 Rural Estate District to MU Mixed Use District. Said lands are described as being in the Township of Laketown, Allegan County, Michigan, described as follows: All that part of the East ½ of the Southeast ¼ of the Northwest ¼ of Section 36, Town 4 North, Range 16 West, lying Northerly of the centerline of U.S. Highway 31, Allegan County, Michigan.



- (2) An Ordinance to amend certain portions of the Zoning Ordinance and Map of Laketown Township, Allegan County, Michigan, specifically by rezoning the land described below from R-1 Rural Estate District to MU Mixed Use District. Said lands are described as being in the Township of Laketown, Allegan County, Michigan, described as follows: Commencing at a point 429.22' East of the Northeast corner of the Northwest ¼ of the Southeast ¼ Section 35; thence East 252.78'; thence South to U.S. 31, thence Southwesterly along said highway to a point directly South of beginning, thence North to the point of beginning, Section 35, Town 4 North, Range 16 West.



The documents pertaining to the proposed amendments may be examined by any person at the Township Hall of Laketown, 4338 Beeline Road, Holland, Michigan 49423 (Telephone (616) 335-3050), on any day of the week except Saturdays, Sundays, and holidays, between the hours of 8:00 a.m. and 5:00 p.m.

The Township of Laketown will provide necessary and reasonable auxiliary aids and services at these hearings, such as signers for hearing impaired persons and audio tapes of printed materials for visually-impaired persons, upon receipt of five days prior notice.
